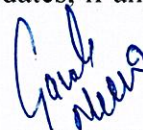

Instructions to Eligible Candidates

1. The place of work is ICAR-NSRI, Indore. Number of posts may be increased or decreased at the decision of Competent Authority. No TA/DA will be paid for attending the test / interview. The decision of the Director of the Institute will be final and binding in all aspects. The application form complete in all respects along with recent photograph and a set of self-attested copies, proof of date of birth, requisite mark-sheets, educational certificates and other supporting documents need to be brought (along with originals) while attending the Interview.
2. Duration: Initially for period up to 31.03.2027 or availability of funds/validity of the project/scheme whichever earlier,
3. Age limit and relaxation: as per GOI/ ICAR norms. Age will be computed from the date of Interview.
4. No candidate will be allowed to appear for the interview if the result of the essential qualification has not been declared or is awaited.
5. The above posts are purely temporary, time-bound, and co-terminus with the project/scheme. Appointment will be based on performance and availability of funds. The terms, tenure, and service conditions of engagement shall be governed by the guidelines/instructions issued by ICAR/NSRI/Funding Agency (as applicable) from time to time. Emoluments will be fixed as per the guidelines of the funding agency in force from time to time.
6. Engagement of YP/SRF/Lab Assistant/Field Assistant shall be regulated as per ICAR rules.
7. Leave and other terms & conditions of the service will be governed by the relevant rules and orders from time to time by NSRI/ ICAR.

8. The number of advertised posts is tentative and may be increased or decreased at a later stage at the discretion of the Director. Only those candidates who fulfill all the eligibility conditions will be allowed to appear for the interview.
9. The engagement of Young Professionals (YPs) at ICAR-NSRI, Indore shall be regulated as per ICAR Office Memorandum No. Agril. Edn.1-06/2020, A&P, dated 04 December 2020, as amended/circulated from time to time.
10. **Reporting Time:** The reporting time on the scheduled date of the interview will be from **09:30 AM to 11:00 PM**. Candidates must report with the prescribed application form, self-attested copies of the required documents, Aadhaar, Experience Certificate, Caste Certificate (where applicable), and No Objection Certificate (NOC) (where applicable). Candidates reporting after the prescribed reporting time will not be considered for the interview.
11. **Experience:** Experience of less than six (06) months rendered by a candidate on part-time/regular basis, daily wages, or as Visiting/Guest Faculty shall not be counted while calculating valid experience for shortlisting. Only relevant experience acquired after obtaining the qualifying degree shall be considered. Selection will be based on academic performance, research experience, and performance in the interview. Selected candidates will be required to produce all original documents along with Medical Fitness and Character Certificates at the time of joining.
12. Candidates already employed must produce a No Objection Certificate (NOC) from their present employer.
13. The selected candidate will be required to work on a full-time basis and shall not be permitted to enroll in any academic programme during the tenure of engagement. The place of work will be ICAR-NSRI, Indore. However, the candidate may be required to undertake outstation duties as per the requirements of the project/scheme.
14. Original documents will be verified at the time of interview/appointment. If any candidate is found to have submitted false information or claims at any stage, his/her candidature shall be summarily rejected.
15. There is no provision for re-employment after completion/termination of the project. The selected candidate shall have no claim for regular appointment, pay scale, or absorption against any regular post in the Institute.
