- 2. The above posts are purely temporary, time bound and co-terminus with the project/scheme. Appointment will be based on the performance and fund availability.
- 3. The terms, tenure and service conditions of engagement shall be governed by the directions of ICAR/IISR /Funding Agency (as applicable) as circulated time to time. Emoluments will be fixed as per the guidelines of funding agencies from time to time.
- 4. Only those candidates will be invited to appear for interview, who fulfill all the eligibility conditions.
- 5. The engagement of Young Professional-I will be governed by the directions of Funding Agency guidelines given in circular of ICAR, New Delhi F.No. Agril. Edn.l-06/2020-A&P Dated 04.12.2020, or as circulated time to time.
- 6. **Reporting Time**: The reporting time will be 09:40 to 11:30 P.M on scheduled date of interview with prescribed application form and self-attested required documents with Aadhar, Experience certificate, Caste certificate (as applicable) and N.O.C (as applicable). The candidates reporting after the reporting time on the above mentioned interview dates will not be considered for interview.
- 7. **Experience**: The period of experience less than six (06) months rendered by a candidate on part time/regular basis, daily wages, visiting/ guest faculty will not be counted while calculating the valid experience for short listing the candidates for test. Only those experiences which are relevant and acquired after the passing date of the qualifying qualification will be considered.
- 8. The selection will be based on academic performance, research experience and performance during the interview. The selected candidates will be required to produce all the original documents and medical & character certificate at the time of joining.
- 9. No Objection Certificate from the present employer is must, if the candidate is already working.
